- 2. No student should be admitted in the above courses till the formal permission of the Board of Governors is granted.
- 3. The Private Medical College should provide Bank Guarantee of required amount in favour of Medical Council of India, New Delhi valid for three years from a nationalized/ scheduled Bank as per MCI's norms. However, medical colleges/ institutions governed by the State Govt. are required to furnish only an undertaking to provide funds in their budget till the facilities are fully provided as per time bound programme indicated by them.
- 4. The Medical Colleges/ institutions will provide undertaking to implement the decision regarding payment of stipend to the PG students similar to PG students of Govt. Medical Colleges in their State.
- 5. The Govt. Medical College(s) (except those colleges located in J&K) should give an undertaking authorizing Medical Counselling Committee (MCC), Directorate General of Health Services, Ministry of Health & Family Welfare, Government of India to include 50% of PG (Medical) seats in All India Quota PG seats for the year 2019-20.
- 6. The Board of Governors reserve the right to withdraw/cancel/revoke the Letter of Intent/Letter of Permission if it comes to the notice that the permission has been obtained from Board of Governors by misrepresentation of fact or fraud.

It shall be incumbent upon the Medical College that the information relating to admission should be submitted within the time specified in the circular in this regards issued by this office from time to time. Any failure to submit the information within this time limit would be construed that the admission in the College were not in accordance with the statutory requirements, thereby enabling the Council to proceed in accordance with law against the college.

Action to grant formal permission of the Board of Governors for increased intake/starting of the said course at your college will be initiated on receipt of appropriate bank guarantee, if applicable and undertaking/ compliance letter fulfilling the conditions enumerated above. The acceptance letter may be sent within 3 days from the date of issue of this letter to enable the Board of Governors to issue Letter of Permission for the academic year 2019-20.
